Each wrapped cylinder is numbered with a unique lot number. The first 10 digits of the lot number represent the production lot, and the next two digits represent the batch sequence number cut from the production lot.

Attention should be paid to the lot numbers in order to avoid visual inconsistencies during use (joining & sewing, etc.) due to tonal differences that may occur between production batches, and products with the same lot number should be put into use first.

PACKAGING FEATURES

Roll Weight; The tolerance on the finished product weights is plus or minus 10%. Roll weight is maximum 35 kg, except for carpet base products and exceptional cases (customers' special requests, etc.).

Length; Product lengths are determined not to exceed the maximum weight.

Width; The minimum usable width of the product between the selvedges is a minimum of 135 cm.

NUMBER OF PARTS

a) Maximum number of parts (cut).

The maximum number of normally acceptable individual pieces per roll of coated fabric is set to 3.

b) Minimum part length.

The minimum part length varies according to the sectoral product groups. The minimum length of a single piece on a roll of coated fabric is not less than three meters

ACCEPTABLE FAILURES; Acceptable punctual errors on the product are maximum 1 in 5 meters. Such errors are maximum 4 in a roll of 40 meters length. For rolls of larger or less length, the defect margin increases or decreases proportionally. The defective area is marked with a label to indicate defects.

Packing; The product is wrapped on a cardboard core with sufficient strength and packed with nylon.

In order to avoid deterioration and damage on the material, the following conditions must be met during the storage phase:

- The products should be stored in a moisture-free environment, not exposed to direct sunlight and should be kept away from heat sources.
- Necessary precautions should be taken to prevent walking and sitting on the products in the stock areas.
- Foreign objects that may damage the product packaging / cause wear / puncture should not be placed on the products in the stock areas, and the stock areas should be kept clean.
- In case the products are transported by forklift or by different methods, attention should be paid and precautions should be taken to prevent damage from possible impacts. The packaging outside is used only to prevent the product from getting dirty and dusty.
- While the products are being unpacked, no intervention with cutting and piercing tools shall be conducted.
- -When the product is received, visual inspection should be carried out before it is taken to the storage area. If any defect is encountered while the products are being unloaded from the delivery vehicle, they should be recorded with a photograph, the situation should be determined with a report, and the relevant customer representative should be contacted.
- In order not to damage the quality and packaging of the products, they should be placed on a clean surface and pallets should be used during transportation.

- The place where the products are placed must be plain. If placed on a pallet, the pallet length should not be shorter than the product length.
- Care should be taken that the loading section shall not contain any contaminants such as water, oil, odoriferous substances, etc.
- Care should be taken that the product rolls do not come into contact with angular protrusions and edges so that they are not crushed or broken during shipment.
- All transportation operations should be carried out in a way that does not damage the product rolls; the product rolls should not be left high, should not be stepped on, the packaging should not be damaged or dragged.
